- Monthly dues are drafted from member's account or charged to a credit card number that is kept on file (NO EXECPTIONS). Please attach a voided check or a photo copy of a credit card with the application for processing.
- Monthly statements are generated the last day of the month with payment due on the 15th day of the following month (for example, statements issued March 31st are due April 15th)
- I acknowledge and agree to familiarize myself with and abide by the by-laws and Rules and Regulations found on the Club's website (www.sulphurspringscc.com) by the terms and conditions for membership of the Club as now in effect or as amended in the future.
- I agree to release for publication all photographs in which I appear, taken in or on property operated by the Club or during a Club function by a staff member or photographer hired by the Club. With my signature below, I am giving up all rights to bring any legal action against the Club based upon use of the photography.
- I understand that I am personally responsible for dues and all other charges and that all amounts due will be paid within thirty (30) days or within other limits fixed by the Club. I understand that delinquent accounts will be suspended or terminated for non-payment as stated below under PAST DUE ACCOUNTS.
- I acknowledge, accept and understand that I am personally liable and responsible for all financial obligations relating to my membership and any of my family members who will be utilizing Sulphur Springs Country Club.

- I agree that any resignation submitted by me shall be in writing to the Club thirty (30) days in advance. I understand that my resignation shall not relieve me of any obligations or indebtedness of mine to the Club and that I remain responsible for all charges, including but not limited to unpaid initiation fees. Resignation shall be sent to SSCC's business office thirty (30) days in advance. Upon resigning former member must wait one (1) year before eligible for rejoining or pay back dues from date of resignation.
- Any upgrade or downgrade of membership requires a one (1) year commitment to the new designated level of membership that has been selected.



- Only Stockholder & Corporate Memberships have charging privileges. All other membership categories are required to pay for Club goods and services upon receipt.
- I hereby acknowledge that all of the statements set forth in this application are true and correct, and that I have withheld no information of a material nature, which would negatively affect my membership application.

PAST DUE ACCOUNTS:

- All members' accounts are to be paid in full by the due date provided on the monthly statement. Any accounts that are 30 days past due can be charged a 10% late fee. The late fee, if charged, will be assessed monthly until the entire balance is paid in full. At such time as any account becomes 60 days past due, and SSCC has not heard from you and/or arrangements to pay your balance have not been made, your membership will be suspended and your account will be turned over to the Board of Directors. Your membership will not return to good standing until the outstanding balance is paid in full. During the suspension period, you may have no club privileges and may make no charges to your account. Any account that is 90 days past due will cause your membership to be cancelled and the club will seek legal recourse against you for all monies due and all costs associated with the collection thereof. In the event I default on my account, I acknowledge and agree I will also be responsible for all 3rd party collection fees, legal fees and court costs.
- I also agree to maintain a current credit card account on file with the Club should my account ever become delinquent and I agree the Club shall have the right to bill such past-due amount to my credit card.
- If your account becomes delinquent, SSCC will notify you by written statement and it will be your responsibility to make an arrangement for payments with the Club.
